Sub: Recruitment to the post of Assistant Director (Textile) in Level -10 of pay matrix as per 7th CPC- Reg.

Vide Advt.No.2/2018 NCDC had, inter alia, invited on-line applications for filling up of one post of Assistant Director (Textile) under UR category. The Corporation had issued admit card to 98 candidates for appearing in the Computer Based Test (CBT) which was conducted on 23/09/2018 (08:30 AM to 10:30 AM). NCDC conducted CBT for short-listing the candidates without examining as to whether the candidate fulfils the eligibility criteria or not. Only after receiving the results based on the merit in the CBT, Corporation has examined as to whether candidates fulfils the eligibility criteria and only such candidates who fulfil the eligibility criteria were shortlisted for **document verification and interview on 08/01/2019.**

2. Out of 98 applicants who were issued admit card for appearing in the CBT for the post of AD(Textile), 75 applicants appeared in the CBT. Based on the performance in CBT, 05 candidates who fulfil the minimum eligibility criteria prescribed for the post, were shortlisted against 01 post under UR category for personal interview. In case where more than one candidate has secured the equal aggregate marks in CBT, tie has been resolved by applying the following methods one after another in the order given below:

- (i) Marks in CBT.
- (ii) Total marks scored in the field of specialization.
- (iii) Date of Birth, with older candidate placed higher.
- (iv) Alphabetical order in the first names of the candidates appeared.

3. Cut off marks (out of 150) of the candidates in CBT short listed for document verification and interview is :82

4. For selection of candidate, weightage for the performance in the CBT and personal interview, as per the advertisement, is in the ratio of 80:20. Based on the aggregate of the scores in CBT and interview, as against 01 post panel of the selected candidate on merit is as follows:-
