The tender document should be accompanied with Earnest Money Deposit (EMD) amounting to Rs.10,000/- (Rupees Ten Thousand Only) in the form of Demand Draft/Pay Order drawn on any Nationalised Bank/scheduled Bank in favour of National Cooperative Development Corporation payable at Bengaluru. The bid addressed to the undersigned in a sealed cover should reach NCDC, Bengaluru latest by 16/03/2018 at 03.00 pm. The bids received in time will be opened on the same day (16/03/2018) at 3.30 PM.

**TERMS & CONDITIONS FOR SALE OF (ONE) OFFICE CAR TATA INDIGO
DLX, PETROL 2008 MODEL (AC)**

1. The tender document can be obtained from the NCDC office on all working days (Monday to Friday) up to 16/03/2018 12.00 noon or downloaded from NCDC's web portal <http://www.ncdc.in>
2. The tenders in sealed envelope superscribed "TENDER FOR SALE OF CAR TATA Indigo DLX Petrol 2008 MODEL (AC)" should reach NCDC, Regional Office, Bengaluru at above address latest by 16/03/2018 - 3.00 PM.
3. The tenders submitted for purchase of said car in format other than the prescribed format at Annexure-I will not be considered.
4. The tender should be duly filled and signed on each page.
5. The reserve price fixed for sale of the car is Rs.1,40,000/- (Rupees One Lakh Forty Thousand Only). Any price quoted less than reserve price will not be entertained.
6. Rates should be quoted both in figures and in words in the bid. In the event of ambiguity in the amount quoted in figures and words, bid amount mentioned in words shall be considered.
7. The vehicle will be sold on 'as is where basis' to the highest bidder. The car sold under the above offer will not carry any warranty/guarantee.
8. The earnest money amounting to Rs.10,000/- (Rupees Ten Thousand only) in the form of Demand Draft/Pay order in favour of 'National Cooperative Development Corporation' payable at Bengaluru drawn on any nationalized bank/scheduled bank should be submitted along with the sealed bid. Tenders not accompanied with earnest money deposit as above, will be rejected as NON RESPONSIVE.
9. The NCDC reserves the right to accept any or reject all the tenders without assigning any reasons thereof.
10. The conditional tenders will not be accepted and summarily rejected.
11. The car will be available for inspection at NCDC's office at Regional Office, Bengaluru on working days (Monday to Friday) between 10.00 AM to 5.00 PM up to 15/03/2018.
12. The successful bidder shall not be allowed to withdraw the bid, failing which earnest money will be forfeited.
13. The EMD of highest 2 bidders will be retained till the sale transaction is completed (i.e. upto 23/03/2018). In the event of the highest bidder failing to make payment and take delivery of the vehicle by 23/03/2018 5.00 PM,

the second highest bidder would be given an opportunity to make full payment of highest bid by 26/03/2018 (5.00 PM) and take delivery.

14. The EMD of unsuccessful bidders (other than 2 highest bidders) will be returned on the day of bidding i.e. on 16/03/2018 from 5.00 PM onwards.
15. The EMD of first highest bidder would be returned on successful completion of all the formalities including transfer of vehicle in his/her/their name. EMD will be forfeited if the bidder fails to make complete payment and take delivery by 23/03/2018, 05.00 pm. EMD of the next highest bidder would be returned on confirmation of transfer of ownership to the first highest bidder. In case, the first highest bidder fails to take delivery, the next highest bidder will be given an opportunity to purchase the vehicle at the price offered by the highest bidder. EMD of 2nd highest bidder would be returned on complete payment and transfer of vehicle in his/her/their name.
16. The earnest money deposit of the successful bidder will be released only after deposit of sale proceeds and transfer of vehicle in the name of bidder.
17. The delivery of vehicle is subject to submission of documentary evidence by successful bidder in support of residential status (Aadhaar card or Ration card or voter ID or Passport)
18. The successful bidder will also be responsible for getting the registration certificate of the vehicle transferred in the bidder's name immediately at his/her/their own cost. NCDC will not be responsible for any lapse on bidder's part in this regard.
19. The car will be transferred in the name of bidder only upon receipt of full payment. The successful bidder has to deposit the full amount of price quoted on or before 23/03/2018 by way of demand draft drawn in favour of National Cooperative Development Corporation payable at Bengaluru drawn on any nationalized/scheduled banks. Failure to do so will result in the cancellation of the offer and earnest money deposit will be forfeited.
20. Govt. tax/ levies/GST applicable shall be borne by the bidder.
21. Tenders received late on account of any reason whatsoever will not be considered.
22. No interest will be paid on EMD on whatsoever grounds & reasons.
23. All the tenders will be opened on 16/03/2018 at 03.30 PM. The tenderer or his representative may be present at the time of opening of the tenders.
