The above Hospital agreed to provide the CGHS (NABH) rates for I.P.D. & O.P.D. treatment. However, those procedures not covered under CGHS, Metro hospital provides 20% discount, Artemis hospital and Venkateshwar hospital provides 15% discount on total IPD/OPD bills (except medicines, consumables implant, packages rates & radiation oncology services).

All the employee (serving & retired) of the Corporation are suggested to avail the services/facilities of the above hospitals to the maximum extent to avoid/minimize the recovery of inadmissible amount under NCDC Medical Attendance Scheme.
