#### **CIRCULAR**

## ENGAGEMENT OF CONSULTANT (MBBS DOCTOR) IN NCDC HEAD OFFICE ON PART-TIME BASIS

The National Cooperative Development Corporation invites applications from willing and eligible individuals for engagement of a Consultant(MBBS Doctor) on part-time basis on remuneration @ Rs.30,000/- per month, having:-

a) MBBS degree

- b) minimum 5 years of experience in handling patients at CGHS dispensary;
- c) worked at level 14 or above pay-scale of CPC.

## Conditions of employment:

- a) Medical consultation is to be given for 2 days in week/8 days in a month(one hour each day)
- b) Payment of lump-sum amount of Rs 30,000 per month including TDS

No other compensation apart from consolidated fee/remuneration will be admissible, even if a person attends office on holidays and works beyond normal office hours.

- 3. The details including eligibility criteria, terms of reference etc. are enclosed. NCDC reserves the right to accept or reject in part or in full or all responses without assigning any reasons whatsoever. Terms and Conditions of engagement are mentioned in **Annexure-I**.
- 4. The last date for receipt of applications, in the prescribed format, is <u>05/11/2021</u> <u>upto 5.30 p.m.</u> Applications received after due date/time will not be considered.

ANNEXURE-I

#### **Terms and Conditions**

## 1. Eligibility

- **1.1.** MBBS
- 1.2. Should have worked at Level 14 or above scale of CPC:
- **1.3.** Minimum 5 years experience in handling a CGHS dispensary

#### 2. Remuneration

- **2.1.** Remuneration of Rs.30,000/- per month (for working for an hour per day for 8 days in a month) will be paid to the Consultant on part-time contract basis.
- **2.2.** Consultant shall not be entitled to any allowance such as DA, transport facility, residential accommodation, medical reimbursement, telephone etc.

#### 3. Conditions

- **3.1.** The Medical consultancy Services will be provided on every week for two days(8 days in a month) as decided by competent authority for one hour from 3 PM to 4 PM.
- **3.2.** In case, visit to NCDC is not possible on any given day for any reason, the absence may be compensated by visiting on subsequent days in the same week, with prior intimation to enable this office to inform the employees in advance.
- **3.3.** If there is absence from work on any day of a week monthly consultancy fee will be paid on pro rata basis.
- **3.4.** In case, working day is a gazette holiday, it shall be treated on a paid holiday in that week.
- **3.5.** Payment of consultancy fee shall be subject to deduction of TDS as per rules.

### 4. Engagement

- **4.1.** The engagement of a Consultant (part-time) will be purely on contract basis and will not confer any right for regular appointment in NCDC or in its associated organisations.
- **4.2.** The contract would initially be for a maximum period of one year and may be further extended on year-to-year basis, subject to functional requirements, appraisal of the performance and medical fitness of the individual.

#### 5. Drawal of Pension

- **5.1.** A retired Government servant engaged as Consultant shall continue to draw pension and Dearness Relief on pension during the period of his/her engagement as Consultant.
- **5.2.** The engagement as Consultant (part-time) shall not be considered as a case of reemployment.

## 6. Deduction of Tax at Source

Income Tax or any other tax will be deducted at source as per Government instructions. Necessary TDS Certificate will be issued to the Consultant.

## 7. Confidentiality of data and documents

- **7.1.** The Intellectual Property Rights (IPR) of the data collected as well as deliverables produced for NCDC shall remain with NCDC.
- **7.2.** No one shall utilize or publish or disclose or part with, to a third party, any part of the data or statistics or proceedings or information collected for the purpose of this assignment or during the course of assignment for NCDC, without the express written consent of NCDC.
- **7.3.** The Consultant shall be bound to hand-over the entire set of records of assignment to NCDC before the expiry of the contract, and before the final payment is released by NCDC.
- **7.4.** The Consultant would be required to sign a non-disclosure undertaking as per Annexure-III.

#### 8. Conflict of interest

- **8.1.** The Consultant appointed by NCDC, shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of NCDC nor will he indulge in any activity outside the terms of employment/ contractual assignment.
- **8.2.** The Consultant shall not claim any benefit/compensation/absorption/regularization of service with this Ministry under the provision of Industrial Disputes Act, 1947 or Contract Labour (Regulation and Abolition) Act, 1970.

### 9. Termination of Agreement

NCDC may terminate the contract to which these terms apply if:-

- **9.1.** The Consultant is unable to address the assigned work.
- **9.2.** Quality of the assigned work is not to the satisfaction of the Officer/ Division of NCDC.

- **9.3.** The Consultant is found lacking in honesty and integrity.
- **9.4.** NCDC may terminate the contract at any time without giving any notice and also without assigning any reason.
