## Sub: Recruitment to the post of Deputy Director (General) in Level - 11 of pay matrix as per 7th CPC- Reg.

Vide Advt. No.2/2018, NCDC had, inter alia, invited on-line applications for filling up of 2 posts of DD (General) (1-UR & 1-ST). The Corporation had issued admit card to 180 candidates for appearing in the Computer Based Test (CBT) which was conducted on 22.09.2018 (04:30 PM – 06:30 PM). NCDC conducted CBT for short-listing the candidates without examining as to whether the candidate fulfils the eligibility criteria or not. Only after receiving the results based on the merit in the CBT, Corporation has examined as to whether candidates fulfil the eligibility criteria and only such candidates who fulfil the eligibility criteria have been shortlisted for document verification and interview.

- 2. Out of 180 applicants who were issued admit card for appearing in the CBT for the post of DD(Gen), 125 applicants appeared in the CBT. <u>Based on the performance in CBT.</u>

  10 candidates (5-UR & 5-ST) who fulfil the minimum eligibility criteria prescribed for the post, were shortlisted in the ratio of 1:5 (vacancy: candidate) against 02 posts (1-UR & 1-ST) for personal interview. In case where more than one candidate has secured the equal aggregate marks in CBT, tie has been resolved by applying the following methods one after another in the order given below:
- (i) Marks in CBT.
- (ii) Date of Birth, with older candidate placed higher.
- (iii) Alphabetical order in the first names of the candidates appeared.
- 3. Category wise cut off marks (out of 150) of the candidates in CBT, under each category, called for document verification and Interview is as follows:-

4. For selection of candidates, as per the advertisement, weightage for the performance in the CBT and personal interview is to be given in the ratio of 80:20. Based on the aggregate of the scores in CBT and interview, as against 02 posts (1-UR & 1-ST) category wise panel of the selected candidates based on merit has been prepared as follows:-
