NCDC vide Advt. No.2/2018 had, inter alia, invited on-line applications for filling up of 05 (UR-3 & SC-2) posts of Programme Officer (General). In the advt. it was stated that no. of vacancies may vary as per requirement. With the approval of Competent authority total number of posts of PO (General) to be filled up was revised to 6 (4-UR & 02-SC). The Corporation had issued admit card to 858 candidates for appearing in the Computer Based Test (CBT) which was conducted on 22.09.2018 (08:30 AM to 10:30 AM) of which 518 applicants appeared in the CBT.

- 2. In the Advertisement No. 2/2018, it was mentioned that for the post of Programme Officer(General), selection shall be based on the merit in CBT and candidates shortlisted based on the merit in CBT, for each of the categories, shall be called for verification of documents in support of age, qualification, experience, caste, category etc. It was also indicated that only applications of such candidates who furnish documents to the satisfaction of the Corporation will be considered. Accordingly, 12 candidates in the ratio of 1:2 (vacancy:candidate)(8 under UR category & 4 under SC category) fulfilling the eligibility criteria for the post of Programme Officer (General), were invited for document verification at NCDC, Head Office on 21.12.2018.
- 3. On the basis of performance in the CBT held on 22.09.2018 (08:30 AM to 10:30 AM) and document verification held on 21.12.2018, the following candidates have been selected for the post of Programme Officer (General):-
