Vide Advt. No.2/2018, NCDC had, inter alia, invited on-line applications for filling up of 10 posts (5-UR, 1-OBC, 1-SC, 1-ST, 1-PH (A) & 1-EXM) of Junior Assistant (General). Admit card to 6352 candidates were issued for appearing in the Computer Based Test (CBT) conducted on 22.09.2018 (04:30 PM - 06:30 PM). Out of 6352 candidates, 3313 applicants appeared in the CBT.

2. In the Advertisement No. 2/2018, it was stipulated that for the post of Junior Assistant, the candidates shortlisted based on the performance in CBT shall be called for test for assessment of computer knowledge along with documents in support of age, qualification, experience, caste, category etc. It was also indicated that only such candidates who furnish documents to the satisfaction of the Corporation will be allowed to appear for the computer skill test. Applications of only such candidates who qualify in the computer skill test shall be further considered and the <u>selection shall be based on the merit in CBT</u>.

3. Accordingly, 37 candidates in the ratio of 1:3 (vacancy:candidate) (UR-20, OBC-3, SC-3, ST-3, PH-3 & Ex-Servicemen-5) fulfilling the eligibility criteria for the post of Junior Assistant (General), were invited for Computer Skill Test & document verification at NCDC, Head Office on 21.12.2018. All candidates having marks not less than the last shortlisted candidate as per the ratio of 1:3, under each category, were also invited for Computer Skill Test. Categories wise cut off marks (out of 150) of the candidates in CBT, under each category, called for Computer Skill Test is as follows:-
