## Sub: Recruitment to the post of Deputy Director (MIS) in Level - 11 of pay matrix as per 7th CPC- Reg.

NCDC vide Advt. No. 1/2021 had, inter alia, invited on-line applications for filling up of 01 post of Deputy Director (MIS) under SC category. The Corporation had issued admit card to 132 candidates for appearing in the Computer Based Test (CBT) which was conducted on 27.06.2021 (04:30PM – 06:30PM). NCDC had first conducted CBT for short-listing the candidates without examining as to whether the candidate fulfils the eligibility criteria or not. Only after receiving the results based on the merit in the CBT, Corporation has examined as to whether candidates fulfil the eligibility criteria and only such candidates who fulfil the eligibility criteria have been shortlisted for document verification/interview.

- 2. Out of 132 applicants who were issued admit card for appearing in the CBT for the post of DD(MIS), 76 applicants appeared in the CBT. <u>Based on the performance in CBT</u>, <u>05 candidates under SC category who fulfil the minimum eligibility criteria prescribed for the post, have been shortlisted against 01 post under SC category for personal interview.</u> In case where more than one candidate has secured the equal aggregate marks in CBT, tie has been resolved by applying the following methods one after another in the order given below:
- (i) Marks in CBT.
- (ii) Total marks scored in the field of specialization.
- (iii) Date of Birth, with older candidate placed higher.
- (iv) Alphabetical order in the first names of the candidates appeared.
- 3. Category wise cut off marks (out of 150) of the candidates in CBT, called for Interview is as follows:-

4. For selection of candidate, weightage for the performance in the CBT and personal interview is to be given in the ratio of 80:20. Based on the aggregate of the scores in CBT and interview, as against 01 post under SC category, panel of the selected candidate based on merit has been prepared as follows:-
