Vacancy Circular

Subject:- Filling up of posts of Chief Director and Deputy Director in the National Cooperative Development Corporation.

It is proposed to fill up posts of Chief Director on deputation cum absorption basis and that of Deputy Director on deputation cum absorption/ direct recruitment basis in National Cooperative Development Corporation (NCDC), a Statutory Corporation of Government of India under the Ministry of Cooperation, as per following details:

- 2. **Eligibility Conditions, Period of deputation/Absorption**: Details are at Annexure –I.
- 3. **Regulation of pay and other terms of deputation basis**: The pay and allowances and other terms and conditions governing the deputation in respect of the selected candidate will be regulated under the provisions contained in the Department of Personnel & Training O.M. No: 6/8/2009-Estt.(Pay-II) dated 17th June, 2010, as amended from time to time.
- 4. **Age-limit:** The maximum age-limit for appointment on deputation basis shall not exceed 56 years and 40 years for the post of Chief Director and Deputy Director respectively and 35 years in case of Direct Recruitment for the post of Deputy Director, as on the closing date of receipt of application.
- 5. Eligible and willing candidates may apply through proper channel in the prescribed format **ATTACHMENT-I**. Cadre Controlling Authorities/Heads of Departments are requested to forward applications of eligible and willing candidates whose services can be spared on deputation immediately on their selection. The applications of only such candidates would be considered that are routed through proper channel and are accompanied by following documents:
 - i Application in prescribed proforma (ATTACHMENT-I).
 - ii Cadre Clearance Certificate from the Cadre Controlling Authority (ATTACHMENT-II).
 - iii Photocopies of the ACRs/ APARs for the last five (5) years duly attested on each page by an officer not below the level of Under Secretary to the Govt. of India and equivalent (ATTACHMENT-II).
 - iv Statement giving details of Major/Minor penalties, imposed upon the officer, if any, during the last ten (10) years (ATTACHMENT-III).
 - v Vigilance Clearance/Integrity Certificate (ATTACHMENT-III).

- 5. As per NCDC Recruitment Rules, absorption of the officer/official in NCDC can be considered on completion of two years of service or earlier on deputation terms subject to satisfactory performance of the officer/official to the satisfaction of the competent authority.
- 6. The application along with required documents may be forwarded to Director (P&A), National Cooperative Development Corporation, 4, Siri Institutional Area, Hauz Khas, New Delhi-110016, by 30th September, 2024. Applications not forwarded through proper channel or those received incomplete or without the requisite certificates and necessary documents will not be entertained. Applicants are required to submit self-attested copies of requisite Educational Qualification Certificates along with Bio-data.
- 7. The candidates who have applied for the post will not be allowed to withdraw their candidature subsequently.

National Cooperative Development Corporation (NCDC), a Statutory Corporation of Govt. of India under the Ministry of Cooperation, was established on 14.03.1963 under the Act of Parliament (NCDC Act of 1962) for economic development through cooperative societies. The major objective of the Corporation is to promote, strengthen and develop the farmers' cooperatives for increasing production and productivity and instituting post harvest facilities. General Conditions:

- i) Candidates selected for the posts are liable to serve anywhere in the country. The incumbent may be posted at Head Office, LINAC, Gurugram and any of the Regional Offices across the country.
- ii) Where there is no vacancy reserved for OBC/SC/ST category, such candidates can still apply. However, they will not be eligible for any relaxations.
- iii) Age limit in case of direct recruitment is relaxable as per Central Govt./ NCDC rules as follows:
 - ➤ Departmental Candidate (Only NCDC Employees) 5 years.
 - ➤ Candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during the period from 01.01.1980 to 31.12.1989 5 years.
 - ➤ Ex- Servicemen 03 Years plus actual military service rendered.
 - ➤ Persons with benchmark disabilities (not less than 40% bench mark disability) 10 years.
- iv) Period of deputation will be 3 years extendable upto 5 years. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department or the Central Govt. shall not to exceed 5 years.
- v) As per NCDC Recruitment Rules, absorption of the officer/official in NCDC can be considered on completion of two years of service or earlier on deputation terms subject to satisfactory performance of the officer/official to the satisfaction of the competent authority.
- vi) The terms & conditions of Deputation/ Absorption basis shall be governed mutatis mutandis by the provisions of the DoP&T's OM dated 17.06.2010 and as amended from time to time.
- vii) While forwarding the application, Cadre Controlling Authority in the Parent Department must certify the details furnished by the candidates in the application format and application must be recommended and forwarded to NCDC alongwith certified copies of APARs for the last 5 years and the latest Vigilance Clearance Report, mentioning inter alia the details of major/minor penalties imposed on the applicant during the last 10 years.
- viii) The application must mention the substantive post in Parent Department and also the substantive pay of the post held by him corresponding to the pay scales of Central Govt. both as per 6th and 7th CPC. The details of financial upgradations under ACP/MACP should also be clearly mentioned.
- ix) For the post of Deputy Director, under direct recruitment, the persons working in Govt. Sector/Autonomous Bodies in Level 7 of Pay Matrix as per the 7th CPC (in pre revised PB-2 with Grade Pay of Rs. 4600/-) or equivalent in other scales will be considered as having working experience in executive/supervisory capacity. In case of persons working in private sector, candidate working in managerial capacity shall be considered as having working experience in executive capacity.
- x) Besides Pay, the posts carry D.A ,H.R.A. and Transport Allowance at Central Govt. rates. Other benefits include New Defined Contribution Pension Scheme, Gratuity, Group Insurance, Medical reimbursement and LTC as per rules of the Corporation. Employment in the Corporation involves liability to serve anywhere in the country.
- xi) The eligibility of the applicant will be determined on the last date of receipt of applications in NCDC. Applications received after the prescribed closing date or not accompanied with the required certificate/ documents are liable to be rejected.
- xii) In the event of number of applications under direct recruitment being large, the Corporation will adopt short listing criteria to restrict the number of candidates to be called for interview to a reasonable number on the basis of desirable qualification, higher educational qualification, higher experience in the relevant field than the minimum prescribed in the advertisement. Mere fulfilling of essential qualifications would not entitle an applicant to be called for interview. NCDC reserves the right to modify the selection procedure, if deemed fit.
- xiii) The applications in the prescribed proforma (enclosed), complete in all respects, should reach the office of Director (P&A), National Cooperative Development Corporation, 4, Siri Institutional Area, Hauz Khas, New Delhi-110016 so that the same may reach the Corporation by **30 September**, **2024**.
