NCDC vide Advt.No.1/2021 had, inter alia, invited on-line applications for filling up of the 05 posts (01-UR, 01-SC, 01-ST & 02-EWS) of Assistant Director (General). In the advt. it was stipulated that no. of vacancies may vary as per requirement. With the approval of competent authority total number of posts of AD(Gen) to be filled up has been revised to 06 of which 2 under UR category, 01 under SC category, 01 under ST category and 02 under EWS category. Out of 06 vacancies, 01 vacancy is reserved for persons with benchmark disabilities of category (a) i.e. Blindness and low vision.

2. The Corporation had issued admit card to 308 candidates for appearing in the Computer Based Test (CBT) which was conducted on 27.06.2021 (08.30AM to 10.30AM). NCDC conducted CBT for short-listing the candidates without examining as to whether the candidate fulfils the eligibility criteria or not. Only after receiving the results based on the merit in the CBT, Corporation has examined as to whether candidates fulfil the eligibility criteria and only such candidates who fulfil the eligibility criteria have been shortlisted for document verification and interview.

3. Out of 308 applicants who were issued admit card for appearing in the CBT for the post of AD(Gen), 172 applicants appeared in the CBT. Based on the performance in CBT, 32 candidates (5-UR, 10-EWS, 06-ST, 06-SC and 05 under PWD Category) who fulfil the minimum eligibility criteria prescribed for the post, were shortlisted in the ratio of 1:5 (vacancy : candidate) against 06 posts (02-UR, 01-SC, 01-ST & 02-EWS) (out of 06 vacancies, 01 vacancy is reserved for persons with benchmark disabilities of category (a) i.e. Blindness and low vision) for personal interview. As per advt. Candidate appointed against PH quota will consume the post from the respective category to which they belong i.e. UR/OBC /SC/ST. All the 05 candidates shortlisted for PH post belongs to UR category. All candidates having marks not less than the last shortlisted candidate as per the ratio of 1:5, under each category, were also been invited for Interview. In case where more than one candidate has secured the equal aggregate marks in CBT, tie has been resolved by applying the following methods one after another in the order given below:

- (i) Marks in CBT.
- (ii) Date of Birth, with older candidate placed higher.
- (iii) Alphabetical order in the first names of the candidates appeared.
