




India Gets Its First FPO Under Cooperative Societies Act

India got its first FPO named "Krishak Utpadak Sanghathan Evam Audyanik Viparan Sahkari Samiti" registered under the ambit of the Cooperative Societies Act in Varanasi, Uttar Pradesh. The FPO will be set up in Tikri village in Uttar Pradesh and will process high-value vegetable products, with a special focus on mushrooms and green chillis. National Cooperative Development Cooperation (NCDC) will look after the Varanasi FPO for the next five years and will also work towards establishing multi-service centre facilities for mushroom production and cultivation.



Assessment of Fisheries Production and Export in India

The fisheries sector remains a prominent contributor to the socio-economic development of India, contributing to food and nutritional security of the nation and providing employment and livelihood to millions of people in the country. Fisheries products are one of the top 3 exports from India. India is the 4th largest exporter of fisheries product and also 18% of agri exports in India consist of fisheries and other marine products. The country exported 13 lakh MT of fish and aqua products valued at USD 6.7 billion in the year 2019-20. India's export basket is primarily dominated by frozen

shrimps, cuttle fish, frozen squids and dried fish. Frozen shrimps contributed ~51% to the total export volume and 73% to the total value (USD 4.9 billion) in the year 2019-20. The top export destinations are USA (38%), China (21%), EU (13%) SE Asia (11%) and Japan (6%).

Given the surplus production of agro products in the country, focus should be made on how to export the same to global markets and to analyze the capabilities and challenges faced in doing so. Marine Sector is very important for the growth of agri exports and it has the capabilities to take the lead to the next level.



Challenges:

The challenges faced in the fisheries exports are as follows:

- Infrastructure and Supply chain gaps-Lack of adequate and modernized infrastructure including landing centres, wholesale markets, cold storages, ice plants and reefer transportation.
- Current focus on limited species- Export is majorly focused on only one variety of shrimp- L. vannamei; and there is a pressing need to diversify focus on other species like Seabass, Pangasius, Tilapia, fresh water prawn etc.
- Export of low value-added products-Currently Indian seafood exports comprise only a small quantity of valueadded products. Frozen Shrimp and fish dominates India's seafood export basket. The Covid-19 pandemic has instigated a major shift towards frozen, packed, ready to eat and ready to cook products. As per MPEDA, only 6-7% value addition done in India as compared to that of 65% in Thailand.
- Food safety infrastructure and traceability- Increasing export parameters by developed countries like Europe and Japan demands orders to be contaminants free. To increase export quantities and reduce rejection percentage, there is a need for introducing robust traceability system in aquaculture.
- Excessive fragmentation in the farm production in both agriculture and aquaculture. So pre and post harvest infrastructure needs to be improved.
- Poor traceability due to lack of digitization among the farmers.

After analyzing the above challenges faced in Indian fisheries production, it is suggested that the Govt. should invest in the following areas for improvement in fisheries export in the country:

- Investment in innovation and product development,
- Investment in product processing and value added products
- Investment in branding is the need of the hour.

Opportunities:

The following opportunities will help in increasing fisheries exports:

- i. Large coastline
- ii. Cost effective labour workforce
- iii. Right climatic condition for marine production
- iv. Supportive efforts by Govt.
- v. Developing countries driving demand and growing consumption

Government Efforts:

Both the Government and private sector industries will have to play a large role in overcoming the challenges. Further State governments should play a vital role in land allocation and infrastructure and other facilitative environment required for rapid growth of aquaculture. Currently the fisheries industry is concentrated on Andhra Pradesh, West Bengal and Gujarat, so to increase the production and export other coastal states should also make an impact in fisheries production and State Govt. should support the same by providing

- Land allocation,
- Processing and Port related infrastructure,
- Cold storage investments,
- Veterinary support and

- Subsidies.
- Focused efforts to incentivize private sector investments in cold chain infrastructure (SAMPADA, FIDF, MPEDA, PMMSY, PLI Scheme etc).

Similarly, the private sector should play an important role in integrating the value chain by

- Putting investments in best practices in the value chain.
- Creating right kind of collaboration with the farmers and aggregators for ensuring maintenance of high quality standards throughout the value chain

so that India can ensure right kind of product in the end market.

Further, COVID-19 has made it clear that business as usual is no longer an option. It is a wake-up call to put people and the environment first. Fisheries are the only commercialized source of wild-caught protein, and they deserve our care and respect. For India, the current focus needs to be on the safety and well-being of fishers, the movement of fisher migrants back to home states and financial and food relief support to fisher communities. Concerted efforts by both the government and the private sector are required to overcome the challenges and boost India's marine exports.






"नया किसान कृषि कानून बिल"

(हिंदी कार्यशाला में चर्चा)

"नया किसान कृषि कानून बिल" 17 सितंबर, 2020 को लोकसभा से पारित कर दिया गया है। इस कानून का मुख्य उद्देश्य किसानों को उनकी फसल की निश्चित कीमत दिलवाना है। इसके तहत कोई किसान फसल उगाने से पहले ही किसी व्यापारी से समझौता कर सकता है, इस समझौते में फसल की कीमत, फसल की गुणवत्ता और कितनी मात्रा में और कैसे खाद का इस्तेमाल होगा जैसी बातें शामिल हैं। इसके अतिरिक्त किसानों और व्यापारियों को एपीएमसी की मंडी से बाहर फ़सल बेचने की आज़ादी होगी। आसान शब्दों में कहें तो कॉन्ट्रैक्ट फ़ार्मिंग में किसानों के आने के लिए यह एक ढांचा मुहैया कराया गया है।

लेकिन जब से यह बिल सरकार द्वारा लाया गया है, इसका विरोध भी देखा जा रहा है और समर्थन भी । इससे लोगों को समझने में काफी दिक्कत हो रही है, कि क्या यह बिल किसान के लिए लाभदायक है या नहीं।

अतः इस विषय पर आयोजित वर्तमान तिमाही की हिन्दी कार्यशाला में उपस्थित सदस्यों ने भी अपने-अपने विचार प्रकट किये । कई सदस्यों का कहना था कि यह बिल कोई नई चीज नहीं है बल्कि इस बिल की समय-समय पर पहले की सरकारें भी या दशकों तक राज करने वाली पार्टियां भी अपने घोषणापत्र में मांग कर चुकी हैं। उनका कहना था कि भारत में जो एपीएमसी मंडियां हैं उसे राज्य सरकारों द्वारा संचालित किया जाता है, पर अब देखा गया है कि कई राज्य एपीएमसी मण्डी से बाहर हो रहे हैं। अतः अभी इस बिल पर संदेह करना जल्दबाजी होगा।

कई सदस्यों का कहना था कि सरकार एम एस पी को बहाल करने की बात कर रही है पर कानून में संशोधन / लिखित में देने को आनाकानी कर रही है जिससे किसानों के मन में संदेह प्रकट होना स्वाभिक है उनका यह भी कहना था कि वर्तमान सरकार पिछले कई वर्षों से कोई भी कान्न पास करती है तो वह विपक्षी पार्टियां या संबंधित ईकाइयों से सलाह मशविरा न करके जबरन संसद में पारित कानूनों को आम जनमानस में थोप रही है। उनका यह भी कहना था कि किसानों का काम खेती करना है ना कि मार्किटंग करना, उन्होने यह भी कहा कि इस बिल से मंडी की व्यवस्था ही खत्म हो जाएगी इससे किसानों को नुकसान होगा और इस क़ानून की वजह से कृषि क्षेत्र भी पूँजीपतियों या कॉरपोरेट घरानों के हाथों में चला जाएगा और इसका सीधा नुक़सान किसानों व भारत में रह रहे लोगों को होगा। अतः उनका कहने का अभिप्रायः था कि सरकार को कॉरपोरेट के बराबर कंपीटिटर की तरह कार्य करना चाहिए ।

लेकिन इस पर कई सदस्यों का कहना था कि कॉरपोरेट जगत को नजरअंदाज नहीं किया जा सकता क्योंकि यह सेक्टर सरकार को सबसे ज्यादा आयकर प्रदान करता है। इससे देश की अर्थव्यवस्था चलती है व कई विकास के कार्य होते हैं। उनका यह भा कहना था कि यह सेक्टर रोजगार देने में भी प्रगतिशील रहा है।

कई सदस्य किसान कृषि बिल पर किसानों के प्रति काफी चिन्तित थे । उनका कहना था कि सरकार को पहले की तरह किसानों से एमएसपी के रेट पर फसल खरीदते रहना चाहिए साथ ही सरकार को इन कंपनियों को सख्त हिदायत /निर्देश देने चाहिए कि वह एमएसपी से अधिक रेट पर ही किसानों से उत्पाद खरीदें।
