3. We undertake to effect payment upon receipt of such written demand, notwithstanding any dispute or disputes raised by the Tenderer in any suit pending before any Court, Tribunal, Arbitrator or any other authority, our liability under this present being absolute and unequivocal.
4. We shall not be discharged or released from this undertaking and guarantee by any arrangements or variations made between you and the Tenderer, indulgence to the Tenderer by you or by any alterations in the obligation of the Tenderer or by any forbearance whether as to payment, time, performance or otherwise.

5. In no case shall the amount of this guarantee be increased.
6. This guarantee shall remain in full force and effect until three months beyond the warranty period as specified in the contract i.e. up to _____(expirydate) [*or until the Corporation has signed the Final Acceptance Certificate (FAC) and has received the contractually agreed Warranty Bond as per the said Contract*]. In case of delay in fulfillment of obligations by the Tenderer, the expiry date shall be extended by us as per intimation from the Tenderer.
7. Unless a demand or claim under this guarantee is made to us in writing on or before the aforesaid expiry date or extended expiry date, all your rights under this guarantee shall be forfeited and we shall be discharged from the liabilities hereunder.
8. Thisguaranteeshallbecontinuingguaranteeandshallnotbedischargedbyanychangeinthe constitution of the Bank or in the constitution of the Tenderer.
9. We lastly undertake not to revoke this guarantee during its currency except with the previous consent of the Corporation in writing.
