

विषय: राष्ट्रीय सहकारी विकास निगम, नई दिल्ली 110016 –निगम मुख्यालय स्टोर में उपलब्ध समाचार पत्रों, पत्रिकाओं, गैर-मरम्मत योग्य डेड स्टॉक आइटम, कंप्यूटर हार्डवेयर/नेटवर्क उपकरण और अनुपयोगी विद्युत उपकरण आदि इंगित चार अलग – अलग लॉट समूह – "ए, बी, सी और डी" के निपटान हेतु।

1. अनुबंध -III के अनुसार वर्गीकृत वस्तुओं के समूह समूह 'ए'- (समाचार पत्र और पत्रिका), समूह 'बी' – (गैर-मरम्मत योग्य डेड स्टॉक आइटम, समूह 'सी' – (कंप्यूटर हार्डवेयर/नेटवर्क उपकरण), समूह 'डी'- अनुपयोगी बिजली के उपकरण आदि की बिक्री निपटान/हेतु मोहरबंद निविदाएं आमंत्रित की जाती हैं।
2. निपटान के लिए वस्तुओं को चार समूहों में विभाजित किया गया है। बोलीदाता चारों समूहों या कुछ समूहों के लिए अपनी दरों का उद्धरण दे सकते हैं। समूह C एवं समूह D के अंतर्गत कंप्यूटर हार्डवेयर/नेटवर्क उपकरण और अनुपयोगी विद्युत उपकरण से संबंधित मद, केवल केंद्रीय प्रदूषण नियंत्रण बोर्ड (CPCB) / दिल्ली प्रदूषण नियंत्रण बोर्ड (DPCC)/ दिल्ली-एनसीआर क्षेत्र में राज्य प्रदूषण नियंत्रण बोर्ड के साथ पंजीकृत स्कैप डीलर, इस शर्त के अधीन कि फर्म द्वारा अपने संबंधित क्षेत्राधिकार में उक्त ई-कचरे के निपटान के लिए एक वचन पत्र प्रस्तुत करना होगा, उक्त ई-वेस्ट के निपटान के लिए बोलियों में भागीदारी के लिए पात्र हैं। ग्रुप C और ग्रुप D के तहत वस्तुओं के लिए अपना प्रस्ताव प्रस्तुत करने के इच्छुक स्कैप डीलर इस प्रस्ताव के साथ पंजीकरण प्रमाण पत्र की एक प्रति प्रस्तुत करेंगे।
3. इच्छुक बोलीदाता निविदा दस्तावेज आवश्यक नियमों और शर्तों के साथ वस्तुओं के विवरण को दिनांक 02.01.2025 तक रा.स.वि.नि. 4, सीरी इंस्टीट्यूशनल एरिया, हौज खास, नई दिल्ली -110016, से निशुल्क प्राप्त कर सकते हैं। निविदा दस्तावेज को वेबसाइट <http://www.ncdc.in/> से भी डाउनलोड किया जा सकता है। निपटान के लिए नियम और शर्तें अनुबंध -I में दर्शाई गई हैं।
4. निविदा के साथ अनुबंध के अनुसार II –“बिड सिक्यूरिटी डिक्लेरेशन फॉर्म” संलग्न करना आवश्यक है।
5. बोलियाँ, उसी दिन अपराह्न 3.30 बजे, बोलीदाताओं के प्रतिनिधि जो उपस्थित होना चाहते हैं उनकी उपस्थिति में खोली जाएंगी। बोली अनुबंध – III में संलग्न प्रोफोर्मा में प्रस्तुत की जा सकती है।
6. बिड डिक्लेरेशन सिक्यूरिटी के बिना, बोलीदाता की बोली प्रस्तावों पर विचार नहीं किया जाएगा और बिना किसी संज्ञान के अस्वीकार कर दिया जाएगा।

The bidders may quote their rates for all the four groups or some of the groups. **For disposal of items under Group C & Group D i.e. computer / computer related items & Un-serviceable electrical equipments, only scrap dealers registered with Central Pollution Control Board (CPCB) / Delhi Pollution Control Committee (DPCC) / State Pollution Control Boards in Delhi-NCR region are eligible for participation in bids for disposal of said e-waste subject to a condition that an Undertaking will be submitted by the firm for disposal of said e-waste in their respective jurisdiction. Scrap Dealers who wish to submit their offer for items under Group C & Group D, shall submit a copy of the registration certificate in this regard along with offer.**



4. The bidders may submit their offers along with "Bid security declaration form" as enclosed at **Annexure- II.**

5. Last date for receipt of bids is 02.01.2025 and the bids will be opened on the same day i.e. at 3.30 PM in the presence of bidders/their representative who wish to be present. The offers may be submitted on the proforma enclosed at **Annexure-III.**

6. **The offers without Bid Declaration Security shall not be considered and rejected without any cognizance.**

7. The Corporation reserves the right to accept or reject complete or part of any offer without assigning any reason.

TERMS & CONDITIONS

1. The items for disposal have been divided into four groups as per list enclosed at Annexure-III
2. The items in respective lot are offered on "AS IS WHERE IS BASIS".
3. The bidders may quote their rates in **Annexure-III** for all the groups or for any/some of the groups. The bidders may submit their offer along with Bid Declaration Security. Sample proforma of Bid Declaration Security is enclosed at Annexure II.
4. Highest price bid for each group will be considered and no objection of any of the firms in this regard shall be entertained.
5. **For disposal of items under Group C & Group D i.e. Computer / Computer related items & Un-serviceable electrical equipments, only scrap dealers registered with Central Pollution Control Board (CPCB) / Delhi Pollution Control Committee (DPCC) / State Pollution Control Boards in Delhi-NCR region are eligible for participation in bids for disposal of said e-waste subject to a condition that an Undertaking will be submitted by the firm for disposal of said e-waste in their respective jurisdiction. Scrap Dealers who wish to submit their offer for items under Group C & Group D, shall submit a copy of the registration certificate in this regard along with offer.**
6. The offers without Bid Declaration Security are liable to be rejected.
7. The items are available for inspection in the premises of Office at Hauz Khas, New Delhi on all working days/hours between from 10.00 AM to 4.00 PM. The sealed offers shall be accepted up to 02.01.2025 **3.00 PM** on and shall be opened on the same day i.e. at 3.30 PM in the presence of bidders who may wish to be present.
8. Offers must be valid for a period of 30 days from the date of closing of tender.
9. The successful bidder will be informed about acceptance of the offer in writing by NCDC. The successful bidder will be required to deposit the payment of the price quoted in the bid within 7 days from the date of issue of letter about acceptance of the offer, failing which the offer will be cancelled. No claim in this regard will be entertained by the Corporation.
10. The successful bidder will be required to take delivery and lift the items within 10 days of depositing the payment. The freight, transportation, packing, insurance for the quantities being lifted, will be borne by the buyers themselves.
11. The items will be delivered on "AS IS WHERE IS BASIS" and no special / extra packing will be provided by NCDC.
12. The quantities sold under the above offer will not carry any warranty/guarantee for the replacements, whatsoever it may be.
13. In case the successful bidder is unable to lift the material within stipulated time period as mentioned above, the offer will stand rejected and bidder will be disqualified from bidding for any contract with NCDC for a period of two years from the date of notification
14. In case of any dispute relating to tender, the same will be referred to Managing Director of NCDC whose decision shall be final and binding.
15. NCDC reserves the right to reject any or all bids in part or full including the highest bid without assigning any reason thereof.
16. All pages of the bid document are to be signed and stamped by the bidder/ firm. The bids other than in the prescribed form shall not be accepted.
