1. The Limited Tenders super scribed with "Tender for Supply of Laptops" may be addressed and submitted to The Director (GA), National Cooperative Development Corporation, 4-Siri Institutional Area, Hauz Khas, New Delhi-110016.

#### 2. Earnest Money Deposit

The Bidder should deposit an E.M.D. of Rs. 15,000/- (Rupees Fifteen thousand only) by Bank Draft drawn on any scheduled bank in favor of "National Cooperative Development Corporation" payable at New Delhi.

- 3. Rate should be quoted both in figures & in words in English in the Rate Sheet. The rates quoted for supply of Laptops as per schedule of quantities at Laxmanrao Inamdar National Academy for Cooperative Research and Development (LINAC), Plot No.89, Sector-18, Gurugram, Haryana.
- **4.** The Tender should be sealed and rate quoted should be inclusive of all taxes, transportation costs, loading and unloading cost, octroi, complete
- 5. The Tender other than in the prescribed form shall not be accepted. Each page of the tender document is required to be signed by the person/persons submitted tender in token of his/her/their having acquainted himself/herself with general terms & conditions, make and quality of items and quantity mentioned in the schedule of quantities.

#### 6. Validity of Tender

Validity of the tender shall be 120 days from the last date of submission of Tender. .

7. If the bidder fails to honor its commitment within the given stipulated period, NCDC will have the discretion to forfeit E.M.D and purchase order may be cancelled.

#### 8. Billing & Payment

Payment of 100 % of the price shall be made by cheque only on satisfactory supply of tendered items. For claiming this payment the Original invoice along with duplicate copy need to be submitted.

#### 9. Delivery Terms

Delivery must be done within 7 days from the date of receipt of award letter. The firm shall supply Laptops at Laxmanrao Inamdar National Academy for Cooperative Research and Development (LINAC), Plot No.89, Sector-18, Gurugram, Haryana.

**10.** The specifications of the Laptops to be supplied are given in the specification sheet.

- **11**. NCDC will not reimburse any charges for losses/damages suffered by the firm while carrying out the supply on the accepted tender.
- 12. The Tender should be duly filled and signed on each page and submitted along with the following documents, (Non submission of these documents may render the Tender invalid).
  - a) Bank Draft for EMD.
  - b) Attested/Photo copy of Experience certificate, supply of Information Technology (IT) Equipments to Govt./Semi Govt. Organizations/ Public Sector Undertaking / Autonomous Bodies/ Subordinate offices of Govt. of India or statutory bodies or Corporations
  - c) GST number of the firm.

#### 13. Interest on Earnest Money Deposit

No interest will be paid on Earnest money deposit on whatsoever grounds & reasons.

#### 14. Refund of EMD Deposit

EMD will be refunded to unsuccessful bidders after the approval of tender. EMD of successful bidders will be adjusted in performance security deposit.

#### 15. Performance Security

The successful bidder(s) shall furnish 3% amount of the contract amount as interest free security deposit after adjustment of earnest money, in the form of demand draft/pay order or Fixed Deposit Receipt or Bank Guarantee valid for a period of 120 days beyond the date of successful completion of supply order of scheduled bank within 7 days from the date of issue of Award Letter and such deposit will be liable to forfeiture in whole or in part in the event of any breach or non-performance of the contract. If the bidder(s) fail(s) to furnish such security deposit within the aforesaid time, his earnest money will be forfeited and the contract shall stand terminated. The performance security shall be released after 120 days of successful completion.

#### 16 Penalty for not completing the supply Job in time

In case the firm fails to complete the supply job within the stipulated time or extended time, a penalty @ 1% (One percent) of the value of incomplete work per week may be imposed on the contractor. The penalty amount, if any, shall be recovered from any amount due for payment to the firm or otherwise. However, the penalty shall not exceed 5% of the Total Work Order Cost and the work order shall stand cancelled without any notice.

#### 17. Signing the agreement

Successful bidder will have to sign the agreement as per proforma enclosed on the Stamp Paper of requisite value within 7 days from the date of issue of offer.

#### 18. Warranty:

The Laptops will be under onsite warranty for minimum one year. The bidder will be responsible to replace free of cost any defective/ broken piece.

- 19. The supply of items mentioned in the schedule of quantities shall be received during working hours i.e. from 10 A.M. to 5:00 P.M. on working days. The supply of items beyond office hours and during Saturdays/Sundays/holidays will be allowed only with the permission of Officer Incharge, NCDC, New Delhi.
- **20.** No advance against material will be given to the firm.
- **21**. The NCDC reserves the right to reject any one or all Tenders without assigning any reasons.
- 22. The quantity of Laptops mentioned in the schedule of quantities may increase or decrease as per the requirement. The Corporation reserve the right to enhance/ reduce/ delete the requirements altogether
