- 4. Highest price bid for each group will be considered and no objection of any of the firms in this regard shall be entertained.
- 5. For disposal of items under Group C (except item no. 15, 16 & 17), Group D & Group G i.e. computer / computer related items, only scrap dealers registered with Central Pollution Control Board (CPCB) / Delhi Pollution Control Committee (DPCC), are eligible for participation in bids for disposal of said e-waste. Scrap Dealers who wish to submit their offer for items under Group C (except item no.15, 16 &17), Group D & Group G, shall submit a copy of the registration certificate in this regard along with offer.
- 6. The offers without Bid Declaration Security are liable to be rejected.

- 9. The successful bidder will be informed about acceptance of the offer in writing by NCDC. The successful bidder will be required to deposit the payment of the price quoted in the bid within 7 days from the date of issue of letter about acceptance of the offer, failing which the offer will be cancelled. No claim in this regard will be entertained by the Corporation.
- 10. The successful bidder will be required to take delivery and lift the items within 10 days of depositing the payment. The freight, transportation, packing, insurance for the quantities being lifted, will be borne by the buyers themselves.
- 11. The items will be delivered on "AS IS WHERE IS BASIS" and no special / extra packing will be provided by NCDC.
- 12. The quantities sold under the above offer will not carry any warranty/guarantee for the replacements, whatsoever it may be.
- 13. In case the successful bidder is unable to lift the material within stipulated time period as mentioned above, the offer will stand rejected and bidder will be disqualified from bidding for any contract with NCDC for a period of two years from the date of notification
