### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. #### 2. Generic

- b) IT System Strengthening: PMU team shall support in maintenance of the exis ting system. IT related activities shall also include study of existing system, d atabase, suggestions for improvements and support and departmental effort s in integration of portal with other portals on the government.
- c) Stakeholders Engagement: Periodic review and follow-up with regional repre sentatives of NDDB, NFDB, NCDC, NABARD, State Cooperation Department f or formation of new multipurpose PACS/dairy/fishery/primary cooperative soc ieties in a time bound manner.

### **TERMS & CONDITIONS**

- Bid should be accompanied with Bid Security Declaration as per the format. Bid s submitted without the "Bid Security Declaration", or any other format will be li able for rejection without providing any opportunity to the bidder concerned. Bid Security Declaration must remain valid for at least 180 days beyond the fina I bid submission date and the validity of the Bid Security Declaration should be extended in the event the last date of bid validity is extended.
- 2. The Bidder should not have been penalized or found guilty in any court of law a nd the consultant shall not have been blacklisted/ debarred by any Central Gove rnment Ministry/State Government/ any other regulatory authority/ and not invo lved in any major litigation that may have impact or compromise the delivery of services required during last five years. Self-Certification by the Bidder on Bidders letter head to be provided.
- 3. Any tour and travels to be undertaken by Project Management Unit (PMU) mem bers in connection to work would be reimbursed by NCDC as per the extant gui delines of NCDC or applicable Government of India norms, whichever is lower. P MU has to obtain prior approval of competent authority of Ministry of Cooperati on/ NCDC for undertaking any tour programme.
- 4. Infrastructure arrangements such as office space, electricity, water supply, furn iture & fixtures, laptops, printers, peripherals supports, office utilities and statio nery will be provided to PMU members. However at the end Of completion of pr oject laptop, printer, scanner and all hardware shall be handed over to NCDC.
- 5. During the assignment period the terms and conditions of the assignment may be modified, if necessary, in order to strengthen / deepen its scope I coverage, All terms and conditions of project guidelines and manual as amended time to ti me shall be applicable in execution of services.
- 6. The contract shall come into force and effect from date of signing of agreement / MOU on stamp paper of requisite value by both the parties.
- 8. PMC is required to submit staffing/ work schedule in accordance to the contract for approval.
- 9. PMC shall confirm availability of key experts and mobilize and deploy the team and ensure that commencement of services shall not be later than 15 days fro m the signing of agreement.
- 10. No excess and extra work shall be carried out without approval of competent a uthority.
- 11. Please note that the terms and conditions of LOA shall form part of the agreem ent, PMC shall transfer all relevant documents/ reports/ presentations/ excel mo dels/ other files related to the above work and deliverables after the completion

of the contract to NCDC.

- 12. During the delivery of reports/ presentation/ other documents, if required, back -up/ supporting data/ working files of given analysis in the deliverables; in such cases, PMC is required to arrange for the sought data (indicating sources thereo f) and consider the same as a part of the deliverables.
- 13. The raw data/ processed data findings shall not be disclosed by PMC to any thir d party without prior approval Of the Ministry of Cooperation/ NCDC.
- 14. The reports and the contents thereof would be the intellectual property of the Ministry of Cooperation/ NCDC and would not be published by the PMC concerne d without prior approval.
- 15. PMU team members shall be appointed by the PMC in consultation with Ministry of Cooperation/ NCDC.
- 16. In case of the change of consultant/ team leader during the course of work, the new consultant/ team leader may be appointed by the PMC in consultation with Ministry of Cooperation/ NCDC.
- 17. NCDC may terminate the contract by giving 15 days notice in writing for breac h of any of terms and conditions etc. or unsatisfactory services/ performance without prejudice to its any rights and remedies against the firms. Further, the c orporation reserves the right to terminate the contract at any point of time with out assigning any reasons thereof.

### **18. NO PRICE VARIATIONS**

No upward revision in the price will be considered on account of subsequent inc rease in foreign exchange. However, if there is any increase/ decrease in gover nment levies/ taxes, during the execution of work, the same shall be passed on to NCDC. All Govt. Levis will be paid on the basis of rates of Levis as prevailing a t the time of making payment. The Bidder shall take into account all conditions and difficulties that may be encountered during the course of assignment, while quoting the rate.

- 19. **EXTENSION OF TIME FOR COMPLETION:** If the agency shall desire an exten sion of time for completion of the work on the ground of his having been unavoi dably hindered in its execution or on any other grounds, he shall apply in writin g to The Director (GA), NCDC with full details within 10 days of the date of the hindrance on account of which he desires such extension as aforesaid. NCDC sh all, if in its opinion (which shall be final) reasonable grounds for extension exists , grant such extension of time as may in its opinion be necessary or proper. No compensation shall be payable to the company for any extension of time.
- 20. Technical proposal will include details of overall approach to the areas listed in this bid along with specific proposals/ solution on each of these areas covering t he recommendations, roadmap implementation, and other crucial aspects. Tec hnical proposal should also clearly articulate the deliverables at the end of each phase of work. The consultancy firm/ successful Bidder is expected to work with NCDC to ensure early implementation of their recommendations, overcoming th e bottlenecks, if any.
- 21. Agency shall transfer all relevant documents/ reports/ presentations/ excel mod els/ other files related to the above Scope of Work and Deliverables to NCDC du ring the exercise and finally after the completion for the exercise.

- 22. The Applicant shall bear all its costs associated with or relating to the preparati on and submission of its Proposal including but not limited to preparation, copyi ng, postage, delivery fees, expenses associated with any demonstrations or pre sentations which may be required by NCDC or any other costs incurred in conn ection with or relating to its Proposal. All such costs and expenses will remain wi th the Applicant and NCDC shall not be liable in any manner whatsoever for the same or for any other costs or other expenses incurred by an Applicant in prepa ration or submission of the Proposal, regardless of the conduct or outcome of th e selection Process.

### 24. CRITERIA OF DISQUALIFICATION

- 1. Failure of any Bidder(s) to provide all of the information / documents r equired in the bid proposal or any additional information/ documents a s sought by the Corporation including supporting documents.
- 2. Misrepresentation in the Bid proposal
- **3.** Bid not accompanied with Bid Security Declaration.
- **4.** Bids which do not comply with the bid conditions or contains counter c onditions. Incomplete or conditional Bid.
- **5.** Use of unfair means/ misrepresentation.
- **6.** Technical Bids containing any price information.
- 7. Companies which have been blacklisted by Central Government or Sta te Governments or Public Sector Undertakings or any Government Bod y etc shall be disqualified from making the bid.
- 25. **Force Majeure:** The agency shall be liable for any delay in execution or failure of their respective obligations under this agreement except for delay caused by occurrence of events beyond control of the company, including but not limited t o natural calamities. fire, explosions, floods, power shortages, acts of God, hostility, acts of public enemy, wars, riots, strikes, sabotage, order/action or reg ulations of government, local or other public authorities. In case a Force Majeur e situation arises, the agency shall immediately notify NCDC in writing of such c onditions and the cause thereof within two calendar days and prove that the sa me is beyond its control and is likely to affect completion of the work. Unless ot herwise directed by NCDC in writing, the agency shall continue to perform its ob ligations under the contract as far as it is reasonably practical, and shall seek all reasonable means for performance not prevented by the Force Majeure event.
- 26. **Arbitration:** In the event of any dispute or disagreement over the interpretatio n of any of the terms herein above contained or claim of liability, the same will b e referred to an arbitrator to be appointed by the Managing Director, NCDC, wh ose decision shall be final and binding upon both the parties. Such reference sh all be deemed to be a submission to arbitration under the Arbitration and Concil iation Act, 1996, The venue of arbitration shall be New Delhi. Subject here to th e court in New Delhi shall have exclusive jurisdiction to the exclusion of all othe r courts.

27. NCDC reserves the right to accept any or reject all the bids without assigning a ny reason whatsoever.
